Registration will only be confirmed upon full payment of registration fees. Deadline for pre-event registration is **15 August 2010**. After this date registration is only possible on site. In the case of cancellation of participation by **31 May 2010**, registration fees will be refunded less an €18.00 handling fee per person. After that date, no further refunds will be issued. Name changes are subject to an €18.00 processing fee per registration. Should participants have any special requests with regard to invoicing, they should advise us when submitting the registration form. A processing fee of €20.00 will be charged if an invoice needs to be re-issued. All prices and details are correct at the time of publishing and are subject to change.
